The Investment Program

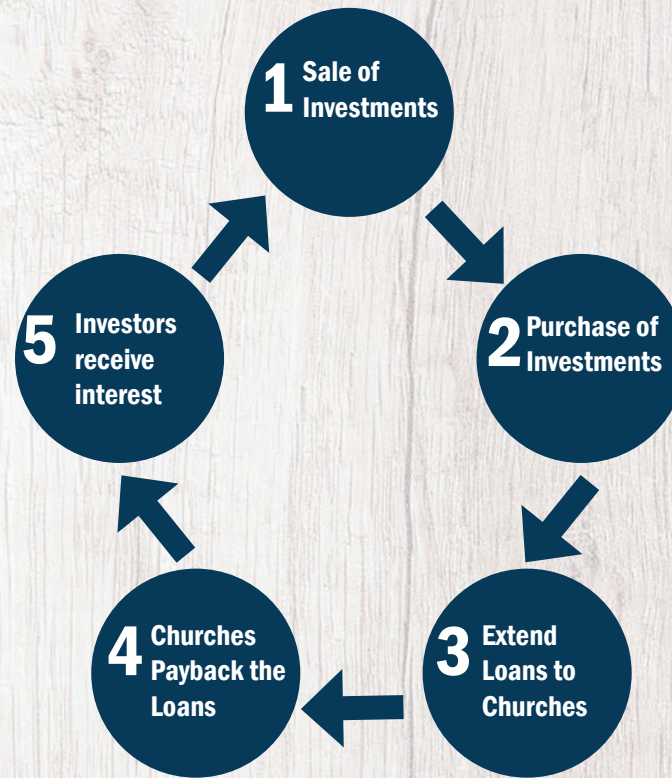
